

Payroll V6.1 Update

The budget announced changes which affect Payroll runs from 5 April 1994. These are:

- tax rate bands changed
- qualifying threshold and period for Small Employers' SSP Relief changed
- no recovery of SSP payments by employers who do not qualify for Small Employer's Relief
- SSP and SMP rates changed
- NI compensation percentage for SMP reduced
- rules for class 1A scale charges changed for 1994/5
- NI rates changed

In addition the Class 1A scale charges and calculation of Class 1A fuel scale charges for 1993/4, to be printed in June/July 1994, have changed.

To effect these changes in Payroll, we have produced zaps 28 and 30.

THESE ZAPS DO NOT IMPLEMENT THE CLASS 1A CHANGES FOR 1993/4 OR 1994/5. The class 1A changes together with changes to SMP due in October 1994 will be in a new payroll release, version 6.2, to be available start May 1994. The 1993/4 class 1A report (required for June/July 1994) should not be run until Payroll 6.2 has been installed.

Zap PR-6.1-28 is a three part zap which effects amendments to calculation of compensation on SSP payments.

Zap PR-6.1-30 is to document a new rates file which contains new National Insurance contribution, tax, SSP and SMP contribution rates. Alternatively, the new rates can be entered using the payroll maintenance facilities.

GLOBAL PAYROLL VERSION 6.1 ZAP 28

Purpose of zap

This zap is to apply statutory changes which come into effect in April 1994.

The changes are:

1. 80% compensation on SSP payments is no longer available for employers who do not qualify as small employers.
2. Small employers are now qualified for NI compensation if they pay SSP for 4 weeks (previously 6 weeks).

Circumstances for urgent application

All sites must apply this zap prior to the first payroll run for year 1994/5 but after end of year for 1993/4 has been run.
