

Urgent Payroll V6.2 update

A problem has been discovered in the upgrade program from Payroll version 6.1 to Payroll version 6.2. Existing court order accumulators set up in Adjust cumulative data are cleared down by the upgrade. As the accumulator is zeroised, no further court order deductions are taken. Also, if Yes is entered to the prompt "Y/N – default court order to non-priority?" the court orders are defaulted to priority and vice versa.

Zap PR-6.2-03 has been produced to fix the two problems in upgrade.

GLOBAL PAYROLL VERSION 6.2 ZAP 03

Purpose of zap

This zap solves a problem in upgrade. The problem is that the protected pay on court orders and amount set up on the court order accumulators may be lost during upgrade. Also, when "Y" is replied to the prompt "Y/N – default court order to non-priority?" court orders are defaulted to priority and vice versa.

Circumstances for urgent application

All

Recovery Required

Use the 'Enter payment and deduction' option to set up correct protected pay, and the 'Adjust cumulative data' to set up the correct amount in the accumulator.

Please note that if you want to keep your Payroll V6.1 menu file you must carry out the amendments detailed in the Payroll version 6.2 release notice prior to upgrading to Payroll version 6.2. Failure to carry out the amendments will result in an EXIT 1 @ 4224 on completion of the upgrade.

If you do not require the Payroll V6.1 menu file, enter 'C' to continue. If RETURN is entered to the

prompt `Key K to keep menu file, C to continue, <ESC>' the old menu file will be kept. If amendments in the release notice have not been carried out this will result in the EXIT 1, as above.
