Payroll P45 changes. This enhancement affects Global Payroll. From 6 th April 1996 legislative changes alter the information required on P45 continuous stationery forms. The content of the form has not altered but conditions governing the appearance/non-appearance of information in boxes 6 and 7 have changed. Status: Coding complete.	95226	01/03/1996 6.4 Main
Retention of Payroll history. This enhancement affects Global Payroll Enquiries. Payslip history now includes details for employees who have left. Each payslip record now offers SSP, SMP, car usage and Class 1 NIC payment details. A new holiday register records holiday days taken for current and past holiday years. Class 1A NICS improvements. This enhancement affects Global Payroll. From April 6 th 1996 legislative changes require a new layout for statutory P11D continuous stationery forms. This feature provides the form required and also offers improved dialogue in the Update Employee Class 1A NIC program. Car value is broken into three parts, original market value, accessories fitted and accessories added. New fields include car usage start and end dates. NIC Holiday for Employers. This enhancement affects Global Payroll. From 6th April 1996, a new feature of National Insurance entitled 'National Insurance Contribution (NIC) Holiday for Employers' is introduced. Payroll now provides for this feature which exists to encourage employers to take on unemployed persons falling into particular categories (eg having been unemployed for two years or more).
