SOP interface to Sales History. The requirement is to enhance Global 3000 Sales Order Processing. A small (22-byte records) extract file must be created during invoice print containing details of the sales order items just invoiced. A new system parameter contains the name of a program to chain once the invoice print has completed in order to process the contents of this file. This program should be repackaged and distributed with Sales History. This interface may also be valuable for other systems.	96013	01/07/1996 4.2 Main
Immediate picking list print. This enhancement affects Global 3000 Sales Order Processing. It permits a single order to be printed on a picking list and allows picking list print to be invoked from within sales order entry, in line with the other sales order processing functions (acknowledgement print, delivery note, invoices etc) already available from the order confirmation menu in sales order entry.	96014	01/07/1996 4.2 Main
A product 'oncost' feature. This enhancement affects Global 3000 Purchase Order Processing. It allows POP to hold a percentage oncost at product code, product group or supplier/product level. Allow negative extra on Purchase Invoice. This enhancement affects Global 3000 Purchase Order Processing. It now has separate options for the addition of extras and addition of service lines and allows for a negative price to be keyed for an extra and reflects this in the line value displayed.	96089	01/07/1996 4.2F Enhanced
Enhancement to Automatic Allocation. This enhancement affects Global 3000 Sales Order Processing. It splits the functionality provided by Automatic Allocation into three phases which can be carried individually or combined. Cash Manager 2000 6.1 BETA Test. A new version (6.1) of Cash Manager 2000. Statement Reconciliation now allows the user to step through unreconciled items and to mark them off against a bank statement. It also allows details from the bank statement to be keyed directly. Autopostings has been generalised allowing information to be posted from any other package. Transaction Entry now has improved dialogue, particularly when entering nominal analysis. Posting to Nominal Ledger is now session based rather than period based.	94009	6.1 Main
Global 2000 Cash Manager manual V6.1. As the V6.0 manual is old style (i.e. documented by menu) and in Global Writer, this job will involve: (1) producing a manual in WordPerfect; (2) converting that manual to the new style (i.e. documented by program & window); (3) documenting the V6.1 enhancements.	94160	6.1 Main
Multiple control accounts in DL and CL. This enhancement affects Global 3000 Debtors and Creditors Ledgers. It allows multiple control accounts when posting to General Ledger. In customer/supplier maintenance the user is prompted for a profit centre and account code to be used as the control account for postings through that customer/supplier account. If either profit centre or account code is left blank, the equivalent item from system parameters is used. Improved Debtors & Creditors daybooks. This enhancement affects Global 3000 General Ledger, Creditors Ledger, and Debtors Ledger. The Daybook layouts have been completely revised to show more information and waste less space. Global Reporter is used for all daybook reports to allow them to be easily tailored. A system parameter allows unwanted narrative lines to be suppressed from the daybook reports. A summary Tax and GL analysis section is now printed at the end of the daybook to match Global 2000 functionality. The end of period report in General Ledger is now optional. Services on delivery notes. This enhancement affects Global 3000 Sales Order Processing. Extras and Services performed at the point of delivery, for example installation, can be printed on Delivery Notes. Equally stocked or non-stocked items such as packaging materials can be suppressed from the Delivery Note while still appearing on the plain paper picking list.	95222	01/11/1996 4.3 Main
Changes to stock reorder report. This enhancement affects Global 3000 Stock Control. Selected fields from the supplier/product record, namely the lead time, last quoted price (including discount and expiry date), and economic order quantity are printed on the reorder report. Multi-currency General Ledger trans. This enhancement affects Global 3000 General Ledger. It now allows transactions to be entered in foreign currency and maintain total amounts posted to each account in each currency. <p>Credit Card Integration. This enhancement affects Global Sales Order Processing. Allow entry of credit card details, setting the credit card type and hold status, and validating the card length and checksum. Import the authorisation or rejection codes, and export payment submission details as the invoice is printed. <p>Template accounts. This enhancement affects Global 3000 Sales Order Processing and Global 3000 Debtors Ledger. A customer account is marked as being a 'Quotation' account. SOP quotations may be placed against this account as usual. <p>Time of order and default sales rep. This enhancement affects Global 3000 Sales Order Processing.
