## **Autozap Run 7088**

This is a 6 monthly run of Autozaps which contains all zaps since run 7082.

Due to the size of the Autozap run, reseller copies only have been distributed for this run. If you require copies for your end user sites please contact Wendy Cook at the City office by fax or email, and for each site give the serial number, name and whether a copy of the full run or a cut down version (excluding the Global 3000 repackages) is required.

A copy of the Autozap Enquiry database is distributed with this run.

There are a number of recovery programs included on the Autozap diskettes.

## **GLOBAL 2000 ENHANCEMENTS**

Zap NL-6.0A-21 introduces a new run time option on P&L statements, allowing either the current exchange rate or an average exchange rate (using rate at point of entry) to be selected for valuing foreign currency postings.

Zap OP-6.3A-02 revises the printing of combined invoices on the summary control report. It now includes the net value of each order next to the order number for combined invoices.

Zap OP-6.3A-03 amends Delivery Note print. The option to print 'to follow' items on format C stationery is now governed by a system parameter 'Print to Follow

Quantity on single column stationery?'.

Zap PR-6.4-72 introduces the amendments required to handle Council Tax Attachment of Earnings Orders that comes into force on 1<sup>st</sup> October 1998. Refer to bulletin GT876 for further details.

## **GLOBAL 3000 ENHANCEMENTS**

Zap ZI-4.4-10 introduces the option of including products with a minimum stock level of 0 on the Understocked Items Report.

Zap ZJ-4.4-04 introduces startpoints for data export from project and sub-project maintenance.

Zap ZM-4.3-53 introduces a standard installation routine for Works Order Processing.

Zap ZM-4.3-58 allows Global 3000 V4.3 to be run on Global System Manager V8.1 revision i, taking advantage of the 'pop-menu' functionality now included as standard in the menu handler \$MH.

Zaps ZM-4.4-11 and ZP-4.4-15 amend the Autopayment parameters so they can be set up on a per company basis. They also introduce the option to set up user-defined Reporter overlays to be used in place of the standard cheque, combined cheque/remittance, remittance advice, bank transfer and remittance list reports.

Zap ZM-4.4-14 introduces a standard installation routine for Bill of Materials and Works Order Processing for Global 3000 V4.4.

Zaps ZM4419, ZP4422 and ZQ4404 allow separate user-definable look up codes to be defined for Creditors Ledger and Debtors Ledger. Prior to the repackages both Creditors Ledger and Debtors Ledger shared the same codes.

Zap ZM-4.4-24 allows Global 3000 V4.4 to be run on Global System Manager V8.1 revision i, taking advantage of the 'pop-menu' functionality now included as standard in the menu handler \$MH.

Zap ZO-4.4-17 enhances the Product/Request Browse screens in Order Entry to show the status of the sales order in SOP.

Zap ZS-4.4-30 introduces the option to print the earliest despatch date, latest despatch date or today's date as the date on a delivery note in Delivery Note print.

Zap ZS-4.4-31 amends acknowledgement print to include the delivery schedule on scheduled orders.
